Fund Overview

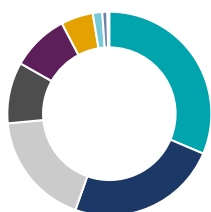

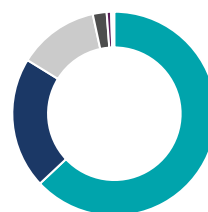

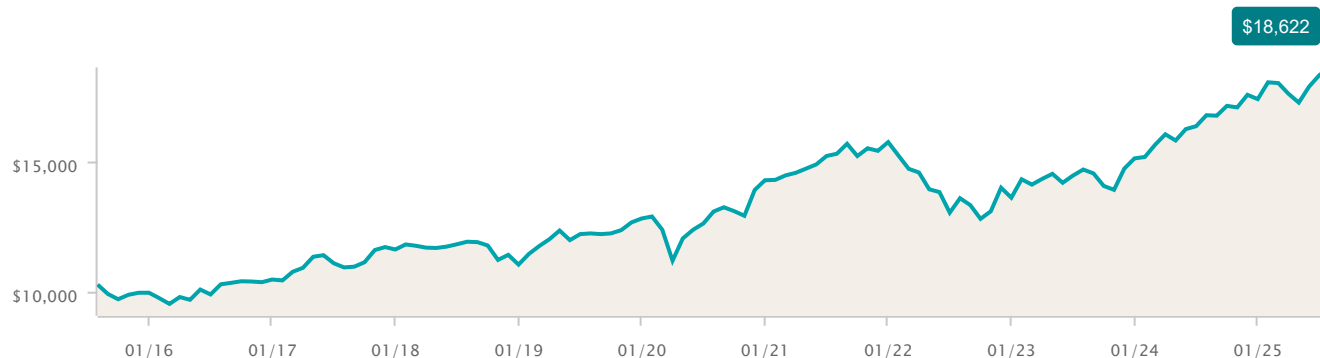
