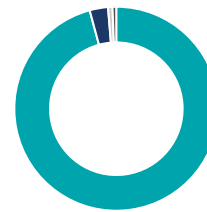

Geographic Allocation (%)⁵

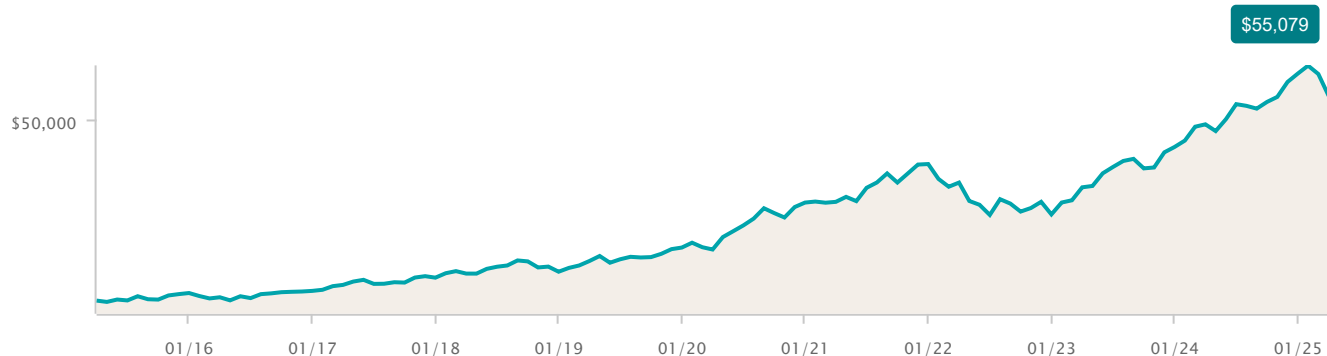
