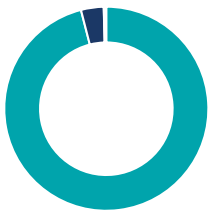

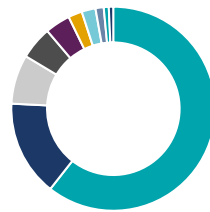

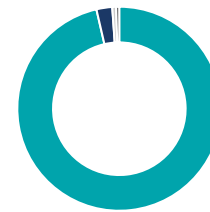

Geographic Allocation (%)⁵

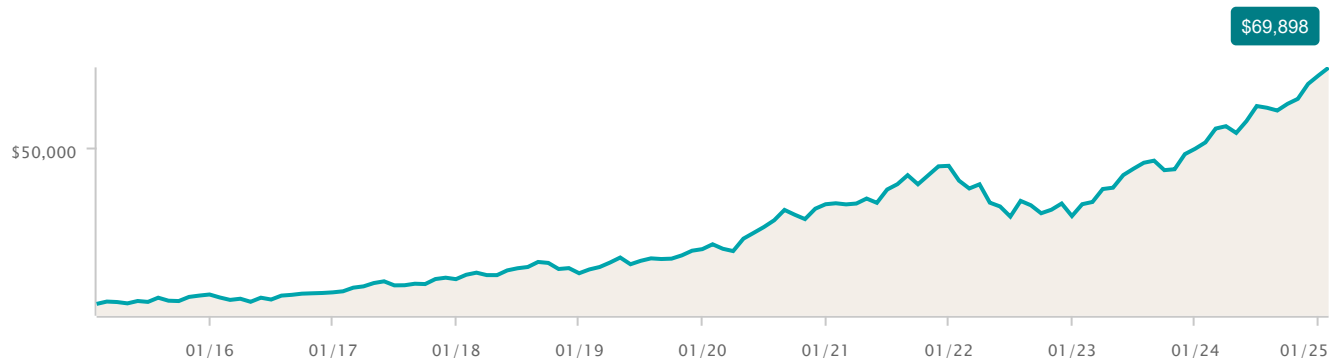
